**PERSONAL GUARANTY**

As consideration for the advancement of electric power service by Alcorn County Electric Power Association (“ACE Power”) to the above named Electric Customer, and to induce ACE Power to provide such electric service, the undersigned Guarantors agree to be individually, jointly and severally liable to ACE Power as follows:

1. Guarantors unconditionally guarantee the prompt and full payment to ACE Power of all of the aforesaid Electric Customer’s present and future indebtedness to ACE Power, without limitation.
2. In the event that the Electric Customer fails to pay any billed services (including, but not limited to, electric power charges, applicable taxes, late fees and penalties), then immediately upon demand by ACE Power, Guarantors agree to pay all such amounts due and owing to ACE Power.
3. Guarantors agree to pay all costs, fees and expenses (including reasonable attorney’s fees and expenses) incurred by ACE Power in the collection of amounts owed by the Electric Customer and in the enforcement of this Personal Guaranty.
4. Guarantors agree that their liability to ACE Power under this Personal Guaranty is direct, unconditional, individual, joint and several, and that ACE Power may seek to collect the entire amount owed by the Electric Customer (including costs of collection and reasonable attorney’s fees and expenses) from any Guarantor without first trying to collect such amounts from the Electric Customer or any other Guarantor.
5. Guarantors agree that ACE Power may use this Personal Guaranty with any financial institution or credit reporting agency for the purpose of obtaining all personal and business financial information of any kind or nature whatsoever, and for any allowable credit reporting purposes.
6. Guarantors hereby waive notice of acceptance of this Personal Guaranty, notice of future provision of electric power services to the Electric Customer, notice of presentment for payment, demand, protest, default and non-payment pertaining to the indebtedness, which is the subject of this Personal Guaranty.
7. This Personal Guaranty shall be continuing, and shall remain in full force and effect, and shall bind Guarantors until either: (i) the Electric Customer’s above account has been closed and all amounts due and owing to ACE Power under such Electric Customer’s power contract and this Personal Guaranty have been paid in full, or (ii) ACE Power consents in writing to the termination of this Personal Guaranty.

**BY SIGNING BELOW, GUARANTORS ACKNOWLEDGE HAVING READ THIS PERSONAL GUARANTY. GUARANTORS UNDERSTAND AND AGREE TO THE TERMS AND CONDITIONS CONTAINED IN THIS PERSONAL GUARANTY AND UNDERSTAND GUARANTORS’ PERSONAL LIABILITY THEREUNDER.**
